



CONTRACT OF SALE AGREED BY BREEDER AND PURCHASER

SOLD AS PET ONLY: The kitten/cat shall not at any time be bred from and shall, on or before attaining the age of six months, be neutered/spayed. Neuter/spay shall be carried out by the breeder's veterinary surgeon prior to collection of the kitten/cat by the purchaser. The purchaser agrees that they understand that the kitten/cat has been spayed/neutered and cannot therefore be bred from.

The kitten/cat shall not at any time be entered in any cat show in any other section other than the household pets section without prior knowledge and written consent of the breeder.

The kitten/cat shall be cared for appropriately in relation to health, physical, emotional, psychological and social needs and shall be given veterinary care when appropriate in relation to health and/or promoting or improving quality of life. If care is not adequate to meet the kitten/cat's health, physical, emotional, psychological and social needs and does not allow a reasonable quality of life (as defined by the breeder's veterinary surgeon), the breeder reserves the right to repossess the kitten/cat without any recompense to the purchaser.

The kitten/cat shall be kept as an indoor only animal and shall not be permitted outdoor access unless a purpose built, fully cat proofed pen or garden is available and used at all times.

The kitten/cat shall not, at any time, be resold or rehomed without the breeder's prior knowledge and written consent. The breeder reserves the right to repossess the kitten/cat should such a situation arise, or to participate in agreeing the new home should it be impractical for the kitten/cat to be returned to the breeder.

The breeder agrees that the kitten/cat is in good health at the time of sale, and that any identified health problems are known to the purchaser in writing prior to purchase. No

responsibility will be accepted by the breeder for any illness occurring after purchase, for any veterinary costs associated with a health condition made known to the purchaser prior to the point of sale, or for any stress related symptoms caused due to the kitten/cat leaving its mother and littermates, from travelling or settling into its new home. The breeder confirms that the kitten/cat will have had at least two vet checks prior to purchase. The purchaser is entitled to have the kitten/cat examined by a veterinary surgeon located within a practical distance from the breeder's premises prior to purchase. The purchaser is responsible for any incurred costs of this health check. Should it be found that health problems which were present prior to sale and known to the breeder were not made known to the purchaser on or before the time of sale, or should the kitten/cat be deemed physically in poor health by a veterinary surgeon, and the breeder informed, within 24 hours of the time of sale, the purchaser has the right to a full refund of the purchase price of the kitten/cat from the breeder upon the kitten/cat's return to the breeder. Stress related symptoms are not considered a sign that the kitten/cat is in poor health. Health problems present before the point of sale must be listed on the kitten/cat's health record with the breeder's veterinary surgeon and must be dated prior to the date of purchase for it to be assumed that the breeder has knowledge of these health problems.

Should any of the above not be adhered to, the breeder reserves the right to repossess the kitten/cat without any recompense to the purchaser.

This agreement is legal and binding, and shall remain in force throughout the life of the kitten/cat.

I, the purchaser, agree that the breeder has fully explained this contract and its conditions in their entirety. I have read and understand the conditions as stated above, and agree to abide by them. I have examined the kitten/cat and have found him/her to be in good health. I have been informed of any pre-existing health conditions and agree that I am willing to proceed with the purchase of the kitten/cat having sufficient knowledge of the disclosed conditions.
